

**GENERAL AGREEMENT
BETWEEN

(hereinafter referred to as NATURIST GROUPS)
AND
CANAVERAL NATIONAL SEASHORE (hereinafter referred to as CANA)**

This GENERAL AGREEMENT (herein known as GA) is made and entered into by and between CANA and NATURIST GROUPS.

ARTICLE I. BACKGROUND AND OBJECTIVES

WHEREAS, the Act of August 25, 1916. 39 Stat 535. And amendments thereto, 16 USC 1 et seq declares that the National Park Service shall promote and regulate the use of the Federal areas known as national parks, monuments, and reservations which purpose is to conserve the scenery and the natural and historic objects and the wildlife therein and to provide for the enjoyment of the same in such manner and by such means as will leave them unimpaired for the enjoyment of future generations: and

WHEREAS the purpose of CANA is, in part, to preserve and protect the outstanding natural, scenic, scientific, ecologic and historical values of certain lands, shoreline and waters of the State of Florida, and to provide for public outdoor recreation use and enjoyment of the same; and

WHEREAS the purpose of NATURIST GROUPS is, in part, to advance and protect the rights and opportunities of naturists to pursue naturist activities: and

WHEREAS CANA and NATURIST GROUPS desire to minimize conflict between clothed and nude bathers in the Volusia County portion of CANA by directing naturist activities to the area south of parking lot #5,

NOW THEREFORE, in consideration of the terms and conditions of this GA, CANA and NATURIST GROUPS mutually agree as follows:

ARTICLE II. STATEMENT OF WORK

A. CANA agrees to:

1. Provide informational signage identifying the historical clothing optional area, which is south of parking lot #5.
2. Issue permit for activity upon proper application.

B. NATURIST GROUPS agree to:

1. Inform and actively encourage their members, as well as others in their community, to voluntarily limit clothing optional activity in the Volusia County portion of CANA to be south of Boardwalk #5.

C. CANA and NATURIST GROUPS both agree to the following:

1. Representatives of NATURIST GROUPS and CANA will meet quarterly to discuss implementation of the agreement as well as assess its effect.
2. Parties to this GA may publish notices regarding the GA.
3. This agreement does not designate a clothing optional area, nor is it a new legal prohibition concerning nudity. As an area of concurrent jurisdiction, all applicable federal and state laws remain in effect for the entire Volusia County section of CANA.
4. CANA reserves the right to exercise its management authority and discretion.
5. CANA and NATURIST GROUPS recognize that this is a one year trial to seek a solution to conflicts between clothed and nude bathers, and that should this attempt at informal resolution not be successful through voluntary compliance, that more formal legal measures may be necessary.

ARTICLE III. TERMS OF AGREEMENT

1. This GA shall be in effect from the last date signed and shall terminate April 15, 2001.
2. This GA will be automatically renewed for an additional year upon each anniversary of the date it becomes effective, up to and including five years, at which time it will be evaluated by the parties for reauthorization.

ARTICLE IV. AMENDMENT

1. This GA may be amended by either party with the written consent of both CANA and NATURIST GROUPS.

The parties will take affirmative action to ensure that participants are invited without regard to their race, color, religion, age, sex, or national origin.

2. OFFICIALS NOT TO BENEFIT: No Member of, Delegate to, Resident Commissioner in, Congress shall be admitted to any share or part of this Agreement or to any benefit to arise therefrom, unless the share or past benefit is for the general benefit of a corporation or company.

ARTICLE VIII. TERMINATION

1. This GA may be terminated by either party upon thirty (30) days' termination notice to the other party via CERTIFIED MAIL, RETURN RECEIPT REQUESTED.
